The Company, along with consortium partner NSDL Payments Bank Limited, participated in the aforesaid Tender. 2. The successful bidder, Purview India Consulting and Services LLP, is alleged to be ineligible for participating in the Tender as tender conditions specify that only Private Ltd or Public Ltd companies are eligible. 3. Allegations include arbitrary evaluation, non-disclosure of technical scores, and award of contract to a higher-priced bidder. 4. Grounds of challenge: violation of mandatory eligibility criteria, arbitrariness, breach of doctrine of 'level playing field', and

		infringement of Articles 14 and 19(1)(g) of the Constitution of India.
